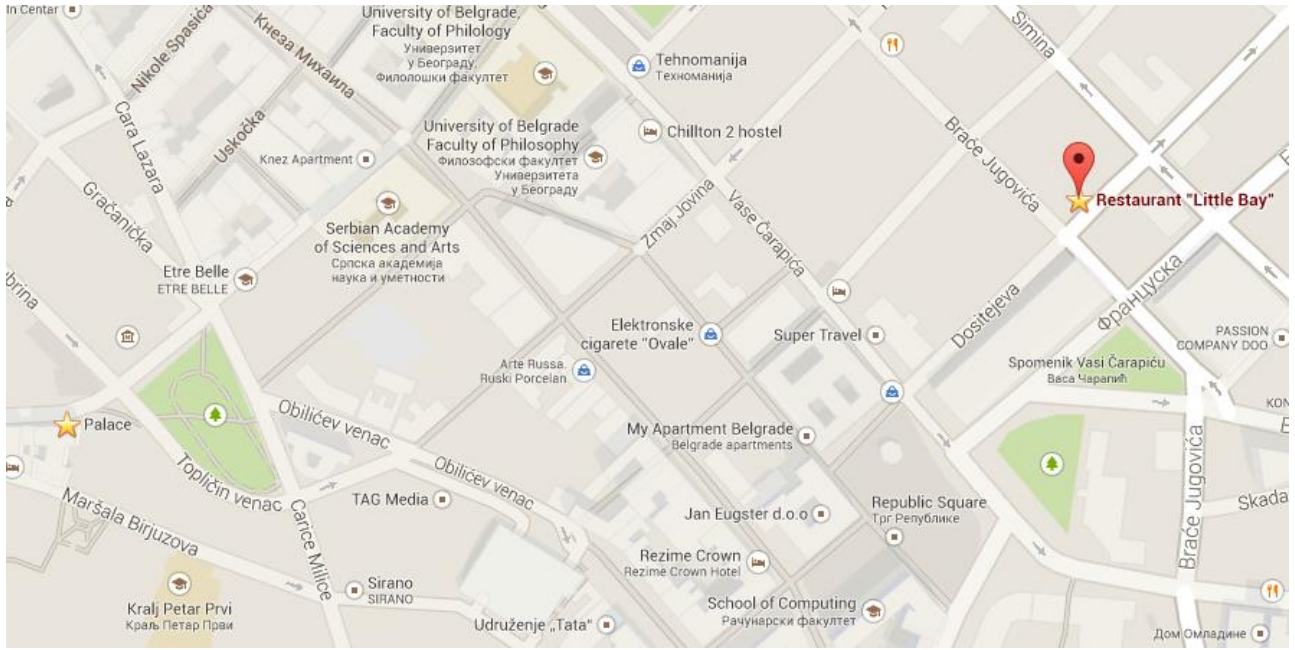

Restaurant *Little Bay* (Wednesday, 19:30)

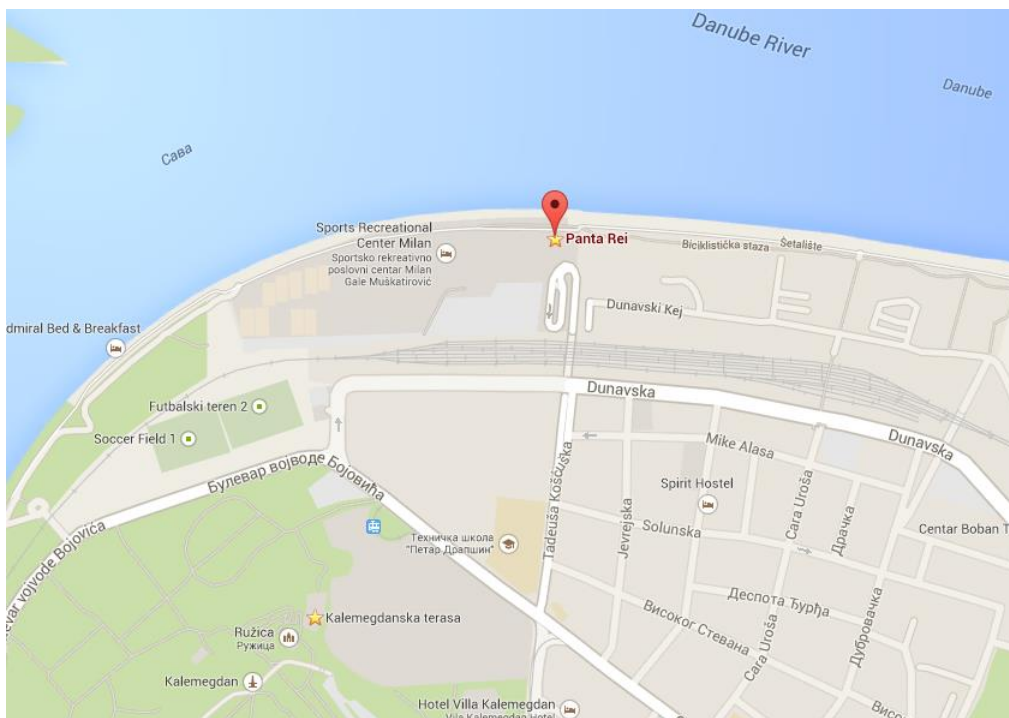

Restaurant *Panta Rei* (Thursday, 19:15)

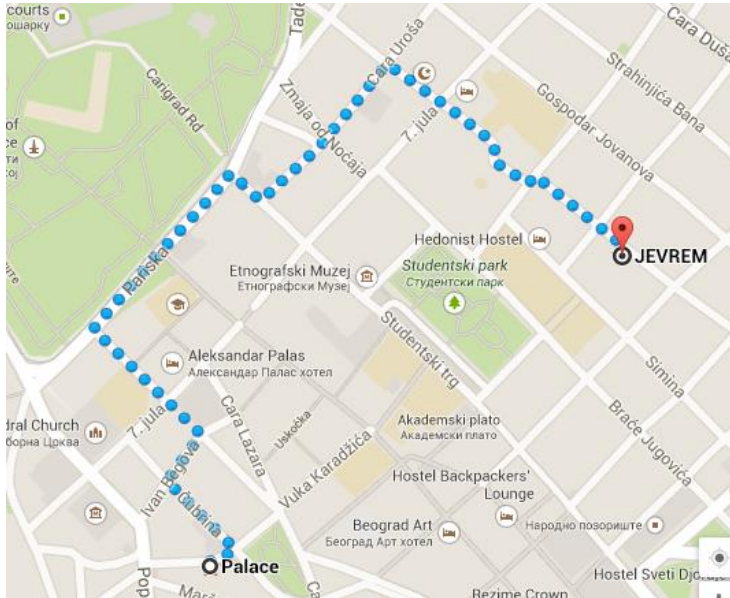
